National Activities

 International Arbitration Conference "International Arbitration and its Role in Attracting Investment and Reconstruction Efforts in Syria"
 27th – 28th of April 2019 - Four Seasons Hotel - Damascus, Syria

International Chamber of Commerce (ICC Syria), held a conference on the occasion of the centennial celebration of the establishment of the International Chamber of Commerce (ICC) Paris in 1919, under the title "International Arbitration and its Role in Attracting Investment and Reconstruction Efforts in Syria".

Under the patronage of Justice Minister, the conference included 4 topics prepared by a selection of distinguished legal experts including judges and lawyers. They were made to include 12 legal lectures on the latest updates of international arbitration in the world. Special attention was given to the rules of the International Court of Arbitration in Paris as well as the general law environment in Syria.



There was also a discussion on the latest developments in the establishment of the Syrian Arbitration Foundation which will have a significantly positive role in attracting foreign investments to the country.

The conference was attended by Justice Minister Mr. Hisham Al-Shaar, Minister of State for Investment, Mrs. Wafika Hosni, Chairman of ICC Syria Mr. Naji Chaoui, members of the Board of Directors and prominent judges and lawyers in the field of international arbitration with around 100 participant.





2. ICC Syria Annual General Assembly 3rd of July 2019 - Cham Hotel - Damascus, Syria

The meeting was attended by the representatives of the Ministry of Internal Trade and Consumer Protection.

In light of this, the General Assembly opened its work headed by Mr. Naji Chaoui, Chair of the Committee's Board / Chair of the ordinary General Assembly.

ICC Syria 2018 annual report was overviewed, in addition to TIR activities nationally and internationally.

The Secretary General, Mr. Khalil Sara, provided an overview of the ICC Academy which provides international accredited courses in the fields of trade finance, banking and institutional work.

ICC Syria board member, Mr. Ahmad Haddad, presented the rules of international arbitration.

ICC Syria treasurer, Mr. Hussein Khaddour, provided an overview of the amendments in INCOTERMS® 2020.

Mr. Shawki Faitrouni, the Executive Manager (TIR Department) presented TIR activities in Syria.

Ms. Mouna Kiwan, ICC Syria Events and Academies Coordinator provided information about ICC and ICC Syria Committees such as: Arbitration Committee, Banking Committee, Intellectual Property Committee and Commercial Law and Practices Committee.

During the Assembly, the accounts of 2018 were approved and an election was made to select the board members for years 2019-2023.

Activities of TIR Syria and the International Road Transport Union (IRU) TIR in Syria and Lebanon 2019

1. Inviting Mr. Umberto de Pretto, Secretary General of IRU June 23, 2019 in Beirut - Lebanon



In conjunction with the convening of the RAME Beirut Conference, on June 23, 2019, TIR Syria Chairman, Mr. Naji Chaoui, invited IRU Secretary-General Mr. Umberto de Pretto to dinner meeting.

Mr. Umberto De Pretto has stated that in the coming stage, Saudi Arabia and Iraq will enter the TIR system and that work for the future, to revive the Silk Road and reach China and East Asian countries; also, the road transportation will be automated, as the transport will become driverless truck locomotives and run on special computers.

1. IRU General Assembly

ICC Commissions

ICC commissions are specialized working bodies composed of business experts nominated by ICC national committees that examine major issues of practical concern to world business and that work together to address cross-cutting subjects. They prepare policy products, including statements to inform and shape intergovernmental discussions and resulting policy, as well as rules and codes to facilitate international business transactions.

1. Arbitration and ADR



Mandate

As a forum for pooling ideas on issues relating to international arbitration and other forms of dispute resolution, the ICC Commission on Arbitration and ADR aims to:

- Draft and revise ICC's Arbitration, Mediation, Expert, Dispute Board Rules and other forms of dispute resolution rules.
- Provide reports, guidelines and best practices on a range of topics of current relevance to the world of arbitration and ADR, with a view to improving ICC dispute resolution services.
- Create a link among arbitrators, counsel and users to enable ICC dispute resolution to respond effectively to users' needs.
- Promote ICC's various dispute resolution services globally.

2. Banking



Mandate

To serve as a global forum and rule-making body for banks worldwide, with particular focus on the financing of international trade; and to help policymakers and standard setters create a regulatory framework that facilitates trade finance throughout the world.



3. Commercial Law and Practice



Mandate

To set global business standards for international B2B transactions and provide world business input on commercial rules developed by intergovernmental organizations.

4. Competition



Mandate

To ensure that business needs and markets are taken into account in the formulation and implementation of competition laws and policies.

5. Customs and Trade Facilitation



Mandate

To promote simplified customs and transport policies and procedures as well as other measures to facilitate international trade.

6. Intellectual Property



Mandate

To promote efficient intellectual property (IP) systems that support international trade, encourage investment in creation and innovation, and facilitate sustainable economic development.



7. Taxation



Mandate

To promote transparent and non-discriminatory treatment of foreign investments and earnings that eliminates tax obstacles to cross-border trade and investment.

8. Marketing and Advertising



Mandate

To promote high ethical standards in marketing by business self-regulation through the Consolidated ICC Code of Advertising and Marketing Communications Practice and formulate world business positions and initiatives to address government actions that affect marketing and consumer protection.

9. Trade and Investment Policy



Mandate

To promote cross-border trade and investment by business and an open global economy to foster job creation, sustainable development, and improve living standards.
