Attar: Italy could be a bridge for all of Europe to Syria



The International Chamber of Commerce -Syria (ICC-Syria), in cooperation with the Syrian Federation of Chambers of Commerce, held the First Conference of Commerce in June 8, 2010 at the Dedeman Hotel - Damascus at the presence of a high-level Italian commercial delegation.

Dr. Abdul Rahman Attar, President ICCS, stressed that his country would move forward with a giant step in adopting Italy as a portal of Syrian exports to Europe. Attar explained that Italy could be a bridge for all of Europe to Syria and that Syria is the best suited for the Mediterranean relationship. Attar described the conference as a 'type' for the beginning of joint work between the Syrian and Italian companies, saying that the Italian machine is present at every factory in Syria. Mohammad Ghassan Al Qallaa, President of the Syrian Federation of Chambers of Commerce pointed out that the commercial relations between Syria and Italy are firmly-established where signing of the first trade deal between the two countries was in 1950. In turn, Achille Amerio, the Italian Ambassador in Syria, stressed on the depth of economic relations between the two countries, adding that Syria plays an important and vital role especially since it is a transit point for all the economic activities.

The opening session was attended by Dr. Ahmad

Abdul Aziz-, General Director of the Syrian Investment Agency, Mohammad Saad Al-Imad, President of the Chamber of Tourism in Damascus and Mrs. Sonia Kachicho, Secretary General of the Syrian Gastronomy Association.

The opening session concluded with a lecture and presentation by Luigi Genuardi, president of the Italian delegation, Board Member of Directors of Palermo Chamber of Commerce. The lecture entitled 'Sicily and its entrepreneurial world' - presented a brief on the Chamber of Commerce, Industry, Handicrafts and Agriculture in Palermo.



Later on, and during four main roundtables, the participants discussed strategies of cooperation, cultural goods, restoration's techniques and handicraft, agro-food sector and tourism and environment and fisheries.

The following day, the Italian delegation visited Homs Chamber of Commerce. A conference was held at the headquarters of the chamber. The conference was attended by Adel Tayara, President of Homs Chamber of Commerce, Labib al-Ekhwan, President of Homs Chamber of Industry, and Mohammed Azzam al Jondi, President of the Chamber of Tourism (Mid Syria). The conference also was attended by a number of Syrian interested businessmen.



MED Digital starts its activities in Syria, Lebanon and Morocco

Carles Revilla, a Spanish expert, visited Syria on May 17 and 18, 2010, during which he held official meeting with Dr. Basel al-Khashi, Deputy Minister of Communication, and Dr. Rakan Razzouk Chairman of the Syrian Computer Society- SCS. Revilla paid a number of visits to

Revilla paid a number of visits to leading Syrian companies working in the field of electronic solutions and the web. He also met with representatives of the regulatory committees and agencies which organize this sector.

The headquarters of the International Chamber of Commerce - Syria (ICC Syria) has hosted workshops Revilla held with representatives of SMEs. Revilla 's visit to Syria comes under the Phase 1 of the MED Digital Project, which comprises situation diagnosis in MED countries (Syria, Lebanon and Morocco), has been already launched.

MED Digital Project – Development of a new service in digital marketing –, which the EU funds 75% of its budget, aims to support and boost the use of electronic solutions and the web as a key and efficient mean to promote and market the products and services of SMEs in MED countries. The EU had contracted with several of bodies to implement the project during the third call of the Invest in Med project. the contractors include: ICC Syria, the Syrian Enterprise & Business Centre (SEBC), The Chamber of Commerce, Industry and Agriculture of Beirut and Mount Lebanon (CCIAB), Estonia Chamber of Commerce and Industry, ACC10 (Barcelona), CGEM (Morocco) Revilla also held several meetings with representatives of the Ministry of Economy and Trade in Lebanon, experts and officials from the Chamber, representatives of companies specialized in electronic solutions via the internet and a number of SMEs with prior experience in using web solutions to promote their products and services, at the chamber's headquarter between May 19 and 21, 2010. In Morocco, The last stopping place in this Phase. Revilla held several meetings with members and representatives of the Union of



Moroccan enterprises in the period between 30 June and July 2, 2010. The meeting aimed to diagnose the status of internet in the country. Another point worth mentioning is that Phase 2 of the project will be launched during the first week of October in the Estonian capital Tallinn during which large scale workshops will be conducted to train employees of partner centres (business support centres) from Syria, Lebanon and Morocco on digital marketing instruments services and provide them with information on the new services and on the mechanism designed to support SMEs and encourage the utilization of e marketing.

David Hamod, President and CEO of National U.S. Arab Chamber of Commerce (NUSACC), visited Syria between July 22 and 25, when he met with Syrian officials and a number of economic and trade leaders.
Hamod stressed that this is his first visit to Syria as President & CEO of the National U.S.-Arab Chamber of Commerce, adding that the objective of his visit was focused on identifying business opportunities in Syria in order to

make American companies aware of best sectors in Syria.
Hamod said he found Syria "encouraging", describing the Syrian business community as "dynamic." "This might come as a surprise to most of the commercial leaders in the U.S.," he said, because "they do not fully understand the Syrian economy and the opportunities here."
During his visit, Hamod met with Dr. Abdul Rahman Attar, President of the International Chamber of Commerce – Syria and Executive

Board member of the NUSACC. The meeting discussed a number of topics aimed at developing the economic relations between the two countries.



The First "Euro-Mediterranean Industry Forum"... 350 operations to serve the business community

With the participation of 250 union and industry leaders in the European Union and South Mediterranean countries, the first Euro-Mediterranean Industry Forum was launched with 'Coalition and Investment Programme for the Mediterranean Forum', which was held in Cairo on April 21-22, 2010.

The investment map of the Southern Mediterranean has been reviewed in addition to the projects which the MedAlliance is implementing in cooperation with the European Union to support trade, industry and investment in the Euro-Mediterranean region. The Euro-Mediterranean integration strategy was developed as well.



The mentioned projects, which are more than 350, are focused on serving the Euro-Mediterranean business community where 280 unions and chambers from both shores of the Mediterranean are implementing them with a budget amounted to 12 million euros, nine of them by a grant from the European Union.

The economic representatives urged the Mediterranean countries' governments to work towards involving the private sector and encourage its active participation in all policies established by UfM.

In Jordan .. A seminar for the revised version of the Uniform Rules for Demand Guarantees (URDG)

The International Chamber of Commerce - Jordan (ICC - Jordan) held a seminar for the revised version of the Uniform Rules for Demand Guarantees (URDG) - bank guarantees - (URDG) on June 21, 2010. The International Chamber of Commerce –Syria has participated at that seminar with a representative from the Arab Bank of Syria.

The seminar reviewed a range of topics including a review of some of the URDG rules, drafting of the demand guarantee, issuing a demand guarantee, amendments to the demand guarantee text and guarantee operations, and application, testing, payment and

completion processes.

The revised rules had enter into force on 1 July 2010. In addition to workers at the banking sector, a group of experts and financial managers has taken part at the seminar and a number of employees in insurance companies and shipping companies.

The URDG, the first in 19 years, is considered the balanced base to regulate the relationship between the beneficiary and the bank issuer of the demand guarantee. It identifies the bank guarantee commitment towards the beneficiary and clarifies the mechanism of the beneficiary claim of his right of the demand



guarantee, and it clearly reflects the international practices followed in this regard.

15 - ICC Executive Board meeting in Hong Kong



The International Chamber of Commerce (ICC) Executive Board held its meeting in Hong Kong between June 27 and 30, 2010.

The meeting discussed many topics concerning the work of ICC commissions. 

Leaders at ICC World Business Summit examine roles of business and trade in development of post-recession global economy



Economic experts said that the world's leaders are at an important crossroads as they tackle the question of how to press forward following the worst recession in decades.

This came at the ICC World Business Summit in Hong Kong on June 30, 2010, titled "New Global Economic Realities: Asia-Pacific Perspectives", organized by the International Chamber of Commerce (ICC) and Hong Kong Trade Development Council.

The Global Business Summit held in Hong Kong on June 30, 2010, entitled "the new global economic realities: the perspective of Asia - Pacific," and organized by the International Chamber of Commerce in cooperation with the Trade Development Council in Hong Kong.

Speakers and delegates at the summit agreed that trade, employment and sustainable development are key drivers of economic recovery and future growth. Victor K. Fung, Chairman of ICC, explained that following the financial crisis and economic downturn of 2008-2009, ICC felt it was important to talk about how the future global economy has been shaped by these events and what we can do to help ensure its stability and growth.

The Summit also gave particular emphasis to Asia-Pacific, the driver of the global economy and the region that proved most resilient during the economic downturn. Green issues and sectors were key focus areas during the Summit.

The Summit involved more than 400 participants, most of whom are senior management, business leaders and opinion leaders from around the region and the world.



International Chamber of Commerce Launches rules (Incoterms ® 2010)

ICC rules for the use of domestic and

international trade terms



A comprehensive revision of ICC's Incoterms rules will come into effect on 1 January 2011, a major step in helping international trade professionals ensure legal certainty and save both time and money.

The new revision, the first in a decade, reflects the profound changes that have taken place in global trade since 2000. These include the importance cargo security has taken for many countries and the 2004 revision of the United States' Uniform Commercial Code, which resulted in a deletion of the former US shipment and delivery terms.

The revised Incoterms rules also reflect the adoption in 2009 by

insurance markets of the revised Institute Cargo Clauses (LMA/IUA) (2009).

Incoterms® rules have been clustered more clearly under two groups -- those appropriate only for maritime transport and those appropriate for sale contracts where any mode or modes of transport are used.

The new rules have been developed to take into account these changes as well as other trends in international commercial practices. The onward march of containerization and point-topoint deliveries, for example, persuaded ICC to introduce two

new «Delivered» terms.



IRU delegation visits Syria

An IRU delegation comprising of Messrs Jan Acri and Talal Al-Waheibi visited the Syrian Ministry of Transport in order to take part in drafting the new transport law.

This comes in the context of the delegation's visit to Syria between June 28 and 30, 2010.

In the presence of Georges Hilal, General Manager of TIR Department in Syria and a representative of the ICC-Syria, and Shawki Faitrouni, Manager of TIR department in Syria, the delegation discussed the new law draft with representatives of the Ministry of Transport.

In order to ensure issuing that system which will



be introduced to interact with the latest global developments in the field of transport, the Ministry of Transport had requested IRU assistance to incorporate European data with the local system.

Syria's accession to the Ask TIR system

March 1 The International Road Transport Union IRU held a workshop on the new AskTIR at the IRU offices in Geneva on June, 11, 2010.

AskTIR software application is a result of significant developments in the world of communication between the IRU and the dissemination of the vehicles movement information to facilitate international road transportation.

Through the International Chamber of Commerce -Syria (ICC-Syria), sponsor of implementation of TIR Agreement in Syria, the country is confirming, via accession to this system, to develop the information of workers in the field of TIR in order to reach the highest levels. Shawki Faitrouni, manager of TIR Department in Syria, and Mohammed Anis, Head of the IT Department at the ICC-Syria, participated at the workshop.
